

LIMITED WARRANTY

- 1) iMonitor equipment is warranted against defects in material and workmanship for 12 months from the date of sale to the original purchaser. This warranty does not cover batteries. iMonitor's obligation under this warranty shall be limited to the free of charge repair (or replacement at iMonitor's sole discretion) of the faulty component(s), which iMonitor finds to be defective in material or workmanship under normal use and service.

Every effort has been made to maintain a high standard of authorised installers, but does not guarantee the quality of the installation.

This warranty is extended to the original consumer purchaser only (non-transferable).

- 2) This warranty is void if damage is caused by, or attributed to, Acts of God, physical or electrical misuse or abuse neglect, repair or alteration without the expressed written consent of iMonitor. The warranty does not cover improper or abnormal usage, damage by water, or faulty installation, unauthorized repair or improper testing. If iMonitor determines such equipment is not operating properly as a result of causes other than poor workmanship or defective material of the product. Charges will be rendered if damages can be attributed to any of the above reasons or if the warranty period has expired.

- 3) **THE OBLIGATION OF IMONITOR SHALL BE LIMITED TO THE REPAIR OR REPLACEMENT ONLY.**

IN NO EVENT SHALL IMONITOR BE LIABLE FOR ANY SPECIAL, COLLATERAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES FOR (i) BREACH OF ANY OF THE PROVISIONS HEREOF, INCLUDING, WITHOUT LIMITATION, PROVISIONS REGARDING WARRANTIES, GUARANTEES, AND/OR INDEMNITIES; OR (ii) ANY CLAIMS BY THE PURCHASER CONCERNING THE GOODS WITHOUT LIMITATION, CLAIMS FOR LOSS OF GOOD WILL, LOSS OF PROFIT OR REVENUES, LOSS OF USE, COST OF REMOVAL, INSTALLATION OR REINSTALLATION, PERSONAL INJURY OF ANY KIND TO THE PURCHASER OR ANYONE ELSE, THEFT OR DAMAGE TO THE VEHICLE OR ITS CONTENTS, AND/OR ANY INABILITY ON THE PART OF THE CONSUMER PURCHASER TO USE THE EQUIPMENT. THIS WARRANTY IS NOT AN INSURANCE POLICY AGAINST LOSS.

- 4) THE FOREGOING WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, WHETHER EXPRESSED OR IMPLIED, OR ARISING BY LAW, CUSTOM, OR CONDUCT, INCLUDING WITHOUT LIMITATION, THE WARRANTIES OF MERCHANTABILITY AND/OR FITNESS FOR ANY PARTICULAR PURPOSE. THIS GUARANTEE IS IN ADDITION TO AND DOES NOT IN ANY WAY AFFECT YOUR RIGHTS UNDER THE CONSUMER GUARANTEES ACT.
- 5) iMonitor makes no other express warranty for this product. No agent, representative, dealer or employee of iMonitor has the authority to increase or alter the obligations or limitations of this Warranty.
